

2009 proved to be a very challenging year for the men and woman of the Tioga County Sheriffs' Office. It was a year that produced the retirement of six employees: Two senior staff members; Captain Paul Rhodes and Senior Investigator Dan Eiklor. Corrections Sergeant Pat Scott; Payroll Clerk Penny Eddy; Corrections Officer Dave Gannon, and; the untimely medical retirement of Deputy Sheriff Daryl Williams. Collectively, more than 100 years of law enforcement experience exited the office. To compound matters, the struggling economy prompted a reduction of operating expenses and staff, leaving our Law Enforcement Division operating the majority of the year with six less officers.

In spite of these reductions our remaining staff continued to demonstrate their commitment and hard work in providing essential services to the citizens of Tioga County.

- For the sixth consecutive year, our office has stayed within budget, finishing nearly 3% under budget, while surpassing our projected revenue intake.
- The Corrections Division saw an increase in the daily inmate population and was successfully awarded Re-Accreditation by the NYS Sheriffs' Accreditation Council.
- The Road Patrol worked the majority of the year six officers short, but succeeded in recording impressive enforcement statistics, as well as answering more than 18,000 Calls for Service.
- With three newly promoted investigators, the Criminal Investigation Division experienced a significant increase in the number of criminal investigations and arrests. Most notably was the apprehension and successful prosecution of repeat sex offender James Galpin Jr, who know faces a potential life sentence for victimizing young boys.
- The E911 center operated the year under staffed, but still handled more than 52,000 Calls for Service.
- The Civil Office continued to processes a considerable number of civil processes, taking in nearly \$700,000 in receipts, while the Records Division showed an increased demand of 17% for pistol permit transactions.

I am proud of all our employees and the effort that they continue to put forth, especially in these difficult financial times. I remain confident and committed to providing professional and fiscally responsible public safety service to the citizens of Tioga County.


#### **Budget**


The Sheriffs' Office overall budget is made up of three component budgets which relate to specific operations within the agency: Sheriff Operations; Jail Operations; E911 Operations


The 2009 budget increased 3% from the previous year. Revenue streams and non-tax base funding sources reduced the tax base burden by nearly 19%.


















## **Grants**

Identifying and applying for state and federal grant funding continues to be a priority and is an important component in meeting our goal of providing cost effective services.

The primary spending focus for these funding opportunities is geared towards replacing or upgrading existing equipment and subsidizing personnel service costs associated with special enforcement initiatives.

Since 2004, the Sheriffs' Office has successfully applied and been awarded more than 1.9 million dollars in grant funding.

### **Governor's Traffic Safety Committee**

Selective Traffic Enforcement Program Grant \$24,120

This grant provides funding to support the deployment of extra patrols to enforce laws which target aggressive driving and, to develop enforcement countermeasures to reduce crashes, injuries and fatalities.



**BUNY Grant** \$3,600

The "Buckle Up NY "grant provides funding to support the deployment of extra patrols to enforce the wearing of seat belts.



Homeland Security Grant \$38,000 Awarded by the NYS Dept of Homeland Security, this grant funded the purchase of radio communications equipment; emergency response equipment, and; personnel costs for emergency response training.

# Special Programs



The Sheriff's Office continues to be an active partner with the NYS Child Passenger Safety Program. Tioga County residents can make a reservation to have their child safety seat inspected as well as instructed on the proper method for installing a child safety seat. During these inspections, seats which are deemed unsafe or appear on a factory recall list will be replaced free of charge.

# **Operation Safe Child**

Using equipment that contains the latest digital fingerprinting technology and high resolution photography, the Tioga County Sheriff's Office provides SAFE CHILD cards for parents and guardians. In the event a child was lost or reported missing, these cards would serve as critical identification for law enforcement.

## Law Enforcement

#### Road Patrol Division

The Road Patrol Division is the primary law enforcement component of the Sheriff's Office. It is staffed by 27 officers.

Their jurisdiction includes all of Tioga County, which covers 524 sq miles with 1,089 miles of highway.

## E911 Emergency Communications Center


The E911 Emergency Communications Center is the sole PSAP (Public Safety Answering Point) for all of Tioga County and serves as the communications hub for all emergency services.

The center is staffed with 13 E911 Dispatchers and operates around the clock each day of the year.



# **Corrections Division (Jail)**

The Corrections Division is the largest component of the Sheriff's Office. It is staffed by 45 full time and 13 part time officers and operates around the clock year long.

The jail is a maximum security facility authorized to hold 104 inmates. Sentenced and non-sentenced male and female prisoners age 16 or older are permitted to be confined in the facility. In addition to housing local prisoners the Jail is authorized and frequently houses inmates from other counties as well as Federal Inmates, Illegal Aliens, NYS Parole Violators, Military Prisoners, and civil confinement prisoners.

The facility operates within the statutory guidelines of the NYS Commission of Corrections.

The total number of inmates processed into the facility during the year (648) decreased nearly 13% from the previous year.


Of the 648 inmates processed, 469 were remanded by courts within Tioga County, accounting for 72% of the jail's population. This represents a 6% decrease from 2008.

The average daily inmate population was 80, which is 1 % higher than 2008.


























#### **Inmate Educational Services**

In partnership with the Owego-Apalachin Central School District (OACSD), the education program at the Jail continues to provide General Equivalency Diploma instruction for both juveniles and adults. The program is directed by Tom Silvanic, of the OACSD and is funded by New York State through the OASD Incarcerated Youth Program.

During the year a total of 20 inmates enrolled in the GED program. Eight inmates participated in the GED examination. Four succeeded in receiving their diplomas.



# Weekend Work Detail (ATI)

(Alternatives to Incarceration)

The Alternatives to Incarceration (ATI) Program has been operating in Tioga County since 1986 and provides the criminal courts with a sentencing alternative through the use of community service.

An important part of the ATI is the Weekend Work Program which is administered jointly by the Probation Department and the Sheriff's Office. Eligible offenders are identified by the Probation Department and are recommended to the Courts. The Courts sentence the offender to the program for a predetermined amount of time. Once in the program, the offenders report to the Sheriff's Office each Saturday and Sunday to perform community service work.

Corrections Officer Roy Schriener oversees all work projects and supervises the details. All work performed is for non-profit organizations, local government, and community based volunteer organizations. The work sites and jobs are planned and approved by Sheriff's Office staff.

## Sheriffs' Civil Office

Under the NYS Constitution, each Sheriff's Office must operate a Civil Office. The Sheriff is a designated enforcement officer of the Supreme Court of New York and is responsible for enforcing lower court mandates.

The Civil Office is responsible for receiving, docketing, and serving civil processes issued by courts within and outside of New York and executing appropriate proofs of service. Their responsibility includes executing court orders, including warrants of eviction, writs of assistance, civil arrest warrants, orders of seizure, orders of attachment, and orders directing the conveyance of real property.

The Civil Office enforces judgments through enforcement of Income and Property Executions; directing the garnishment of wages; Delivery of real property and the sale of real property at public Sheriff's sales. The proceeds of these enforcement procedures are collected and disbursed to the judgment creditors on a monthly basis. Sheriff's fees received for the service and enforcement of civil process and mandates are collected pursuant to law and remitted to the County Treasurer.

The office is staffed by a Civil Manager and a Law Clerk and is in operation during the daytime hours, Monday through Friday. Two part-time Deputy Sheriffs are assigned to provide personal service of processes.

## **Records Office**

The Records office is responsible for managing all legal documents generated by the Sheriff's Law Enforcement and Corrections operations. In addition to the traditional archival duties, this office interacts with the public and a variety of private and government organizations.

Dissemination of records and information are routinely performed for such agencies as: Insurance Companies; Dept. of Social Services; Dept of Health; U.S. Military; Private Attorneys; local, state and federal courts.

The office is staffed by two civilian employees and operates during regular business hours.

#### **Pistol Permits**

The Sheriff's Office is responsible for processing and managing all Tioga County Pistol Permits, Gun Dealer, and Gun Smith Licenses. The issuing authority for all permits and gun licenses is Tioga County Judge Vincent Sgueglia.

The Sheriff's Office supports Judge Sgueglia by performing all administrative duties and background investigations. The Sheriff has authority to issue an official recommendation for granting or denying a license or a permit. To help defray some of the operating costs in performing these duties, the Sheriff's Office is permitted to charge a predetermined fee for each type of transaction.



## **Community Outreach**

### NYS Sheriff's Summer Camp Iroquois

The Summer Camp Program, founded in 1977, was established by the Sheriffs to aid and enhance the development of the state's youth. Each year, as many as 10 children from Tioga County are selected to participate in the program, with all expenses being paid by the Sheriff's Association.

The children are selected with the help and input of area school officials and youth advocates who identify eligible children who they believe will benefit most from the experience.



The program is designed to foster a stronger relationship between the children and law enforcement and to give children, who ordinarily would not have the opportunity, a chance for a summer camp experience.



Located on the shores of Keuka Lake, outdoor learning activities, with professional instruction, are the cornerstone of the camp's recreational program. Team sports are also emphasized as a vehicle to reach comradeship and discipline.

Sheriffs' Offices from across the state volunteer Deputy Sheriffs to supplement the professional staff. The deputies spend a great deal of time with the kids, with many of them conducting demonstrations in the fields of archery, boating, water safety, and police dog exercise, to mention only a few.

For the fifth consecutive year the Tioga County Corrections Union sponsored an Annual Christmas Dinner at the Countryside Community Center in Owego.
